2012 Application/Contract for Membership

I, the undersigned, being of full legal majority, do hereby submit this application for the Krewe of Excalibur (hereafter KOE) for Membership for the 2012 season.

Attached is a deposit of \$ _____ (\$100 minimum). I understand that if I choose to discontinue my membership to the Krewe at a later date, this deposit and/or any monies paid will not be refunded.

Upon acceptance, by the Board of the KOE, as a member for the 2012 season, I agree to be bound by the Charter and By-Laws of the KOE, the Laws of the State of Louisiana and applicable Parish and/or Municipal Laws. In addition, I agree and affirm that no objects may be manufactured, imprinted, marketed, etc. by me or my agent, utilizing the organizational name, crest, logo, etc., in any form whatsoever, nor may objects be marketed to any member in competition with objects sold by the KOE, without the expressed written permission of the KOE.

Also, I hereby acknowledge and agree to Pay In Full indebtedness on my member account by January 1, 2012. I acknowledge that if I do not pay in full by January 1, 2012, I will be charged an additional late fee of \$50.

In consideration for full payment of membership dues, the KOE agrees to furnish items listed as per dues Tiers A, B, or C listed in box.

It is further agreed that the KOE will furnish the articles in each tier upon acceptance of said membership dues, unless the parade and/or ball are cancelled due to war, Civil disturbance, strike, weather, mechanical conditions beyond our control, or national disaster.

Members are respectfully reminded that the KOE was organized and exists to foster and encourage social relationships of a personal nature among its members and that business-related discussions and activities have always been considered to be incompatible with this objective and out of place at all KOE functions.

Consistent with the purely social and distinctively private character of the KOE, payment by third parties of dues, fees, bills, or any other payments will not be accepted. Similarly, it is contrary to the KOE's policy for a member to be reimbursed by any non-member for KOE dues, charges, or fees. Members are advised that such payments to the KOE may not be claimed as a business deduction or expense for income tax purposes.

Additionally, said Member acknowledges his understanding of all rules and regulations governing behavior, and that said member agrees to assume all risks associated with participation in the parade and associated activities, and agrees to release the KOE, its officers and directors, employees, agents and members from any and all damages or losses sustained by the Member as a result of his participation in the parade and related activities.
